INFORMATION COLLECTION AND USE

Casa Systems automatically receives and records information on our server logs from your browser including your IP address and the page you requested, and we routinely collect information such as webcast time-stamps and logs events.

RETENTION AND RELEVANCE

Casa Systems uses and retains only your PII that is directly relevant to the purpose for which it is collected. This information is retained as you provide it but will be updated when you notify us of changes in order to maintain its accuracy.

INFORMATION SHARING AND DISCLOSURE

Casa Systems will not sell or rent your PII to anyone.

Casa Systems will send PII about you to other companies or people only when:

- We have your consent to share the information;
- We need to share your information to provide the product or service you have requested;
- We need to send the information to companies who work on behalf of Casa Systems to provide a Casa Systems product or service or to otherwise assist Casa Systems with its business activities. (Unless we tell you otherwise, these companies do not have any right to use the PII we provide to them beyond what is necessary to assist us, and are required to safeguard PII and not to disclose PII to others).
